#### 2025/159 APOLOGIES FOR ABSENCE

#### 2025/160 DECLARATIONS OF INTEREST IN AGENDA ITEMS

No declarations of interest in agenda items were tabled.

#### 2025/161 CHAIRMANS OPENING REMARKS

The Chair read the following statement:

Over recent weeks there has been a significant amount of correspondence received from members of the public, many relating to the land owned by the Parish Council in Copse Lane. These are noted by Council. The Parish Council is also aware of social media posts and comments on this matter.

On behalf of the whole Council, I would like to make the following statement to clarify the position.

Following receipt of a valuation requested by the recreation field task and finish group who along with the play area task and finish group are looking into medium- and long-term investment opportunities and benefits for the village, the PC agreed to form a further 'task and finish group' to consider options, costs, timelines and many other matters that may possibly lead to planning permission for the land at Copse Lane being pursued. The three task and finish groups, whose work is closely aligned, will report back to full Council at future meetings with their findings and recommendations. Only at that stage will Council be asked to make any decisions. Council is aware that some residents feel the village should be consulted on the Copse Lane land. Depending on the need and recommendations made by the three task and finish groups, Council will consider the most appropriate method of engagement with its key stakeholders.

#### 2025/162 APPROVAL OF MINUTES

Members **RESOLVED to APPROVE** the minutes of the meeting held on 19th August 2025 with one amendment to the published draft minutes, that being to add to min ref 2025/139 the following 'A MoP stated the land at Copse Lane is an asset that belongs to the village and its residents and that Council should hold a public consultation before the land is sold'

#### 2025/163 PUBLIC SESSION

Eight members of the public (MoP) raised various comments and concerns to Council, the majority being associated with the land at Copse Lane, currently being offered to local organisations and businesses for use as a car park. Points noted by Council were concerns over displacement of cars onto Copse Lane, residents' opposition to the land being sold for development, what benefits would be realised to the village with proceeds from any sale, the land currently being used as a car park is a community asset, no more houses are required in the village, no consultation with parishioners, impact on Merryfield Hall and Council should encourage the use of the car park, the land should be turned into a 'proper' car park and focus should be on speeding issues.

A series of questions were raised and noted by Council, including can a Parish Council legally sell an asset that is used regularly by the community, without first consulting with the residents. If no legal reason dictates, should the PC, under its obligation to act on behalf of the residents, morally consult with community, and if so, would it make sense to consult 'before' undertaking any research and/or spending any money. Have the Council got a purchaser for the land; how would residents go about calling for a 'vote of no confidence' in the Parish Council. Where would the Council expect the Wyndham Arms, Cricket Club and Village Hall customers to park. How much would you expect to sell the land for and have the Parish Council identified a use for the income. Do the Parish Council have any prospective purchasers. Have Council considered leasing the land to any of the car park users. Should the Parish Council pursue the sale of the land for development, have they considered making Copse Lane from the Village Hall to the T junction, at the north end, one way. The Clerk agreed to respond in writing to the question set on behalf of the Council.

Two members of Avon and Somerset Police force attended the meeting stating the village experiences low levels of crime and anti-social behaviour. They encouraged reporting of incidents witnessed, these can be made via 101, on-line or Crimestoppers, which reporting can be anonymous. For serious events, 999 is the preferred option.

Assertion 10, digital and data compliance requires Councillors to have separate email accounts for Council business with best practice using .gov.uk domains for emails and website. Council is currently compliant here. A data protection officer should be formally appointed by Council. It was agreed to cover this and the adoption of an IT policy at a future meeting. Councils' website meets the required accessibility requirements, however an accessibility statement to the home page of the website is needed.
